1. Check-in starts at 14:00 and ends at 12:00 on check-out day. Guests who check-in with lunch have breakfast and dinner on the day of departure, and guests who check-in to the hotel can have breakfast and lunch on the day of departure.

2. The Delegate and/or the Company declares and undertakes to carefully use the fixtures in the venue where the organization will be held.
